Dear Chairman Shelby, Vice Chairman Leahy, Chairwoman Lowey, Ranking Member Granger:

As strong supporters of the U.S. Department of Agriculture (USDA) Research, Education, and Extension (REE) mission area, we write to express our united and steadfast opposition to the USDA's relocation of the Economic Research Service (ERS) and the National Institute of Food and Agriculture (NIFA) from Washington, DC to Kansas City, MO. Earlier this year, the House of Representatives passed an FY2020 Agriculture Appropriations bill that would prohibit funding for the relocation of ERS and NIFA outside of the National Capital Region. We urge conferees to adopt the House position in the final FY 2020 Appropriations bill text.

In August 2018, the USDA proposed a costly, legally questionable, and ill-advised relocation of the Economic Research Service (ERS) and the National Institute of Food and Agriculture (NIFA) outside of Washington, DC.<sup>1,2,3</sup> With no opportunity for stakeholder input provided throughout the process, the USDA announced its decision to relocate these agencies to the Kansas City Region in June 2019. Furthermore, in relocation orders to employees, the USDA offered an unreasonably short window of time for employees to decide whether to relocate or not.

Since the initial announcement more than one year ago, USDA's management of the relocation could be described as willfully negligent. This, in turn, has created tangible and immediate problems for the stakeholders that USDA was created to serve. Despite baseless claims of the

improvements that the relocation would bring, USDA has left its key stakeholders to deal with the following facts:

- A staggering 75 percent of staff have left ERS and NIFA, including all of the grants management staff at NIFA and publishing staff at ERS<sup>4</sup>
- Important research dollars from NIFA's \$1.7 billion portfolio are being significantly delayed to our nation's premier research institutions.<sup>5</sup>
- Dozens of critical ERS reports have been delayed or discontinued, including those on the opioid epidemic, international trade markets, SNAP, veterans' diets, and the consolidation of dairy farming.<sup>6</sup>

The harm done to American farmers, food and agricultural science, and hardworking federal employees at the hands of USDA is astonishing, but not irreversible. Absent USDA's desire to fulfill its own mission to – “provide leadership ... based on public policy, the best available science, and effective management” – we ask that you fight against the dismantling of ERS and NIFA for the best interest of American food and agricultural research, and the millions who depend on it.

We urge you to adopt the House-passed language prohibiting funding for the relocation of ERS and NIFA outside of the National Capital Region in the final FY 2020 Appropriations bill text.
